## Update on Share Repurchase Program 2018bis

In the framework of the Share Repurchase Program 2018bis, as announced on June 25, 2018, the Company reports today that during the period from February 25, 2019 until March 1, 2019, the following transactions took place through the central order book of the regulated market of Euronext Brussels:
